## TERMS AND CONDITIONS OF MEMBERSHIP

Your registered credit card will be charged for the amount due and payable upon delivery confirmation of your membership card. A sms will be sent to inform you of the initial charges, if any.

The following terms and conditions govern the rights and obligations of all members of 'The Valet Club'. The applicant of the club membership (hereinafter referred to as "the Member") by signing the said applicant form shall be deemed to have read and accepted the terms and conditions of membership herein contained.

### 1. THE VALET CLUB

1.1 FIELDCREATIONS TVC SDN. BHD. (Company No. 1009699-K) (hereinafter referred to as "the Promoter") is the proprietor 'The Valet Club' and is carrying the business of promoting and selling membership packages in 'The Valet Club' where members are entitled to valet parking services at selected establishments within Kuala Lumpur and Selangor region only (hereinafter referred to as "Establishments") operated and/or owned by valet operators (hereinafter referred to as "Service Providers") appointed by the Promoter.

1.2 The membership shall be effective as of the date that the Promoter executes and confirms its acceptance of the membership application after the submission of the membership application by the Member to the Promoter and payment by the Member of the Membership Fee in accordance to the terms herein. The Promoter reserves the right to reject any new membership application at their absolute discretion.

### 2. THE SERVICES

2.1 Subject to the terms and conditions hereinafter contained and in consideration of payment of the Membership Fee hereinafter defined, the Promoter shall upon acceptance of the Member's application grant to the Member the rights to enjoy valet parking services (hereinafter referred to as "the Services") at the Establishments in accordance to the type of Membership Package chosen by the Member in the membership application.

2.2 The Member shall be entitled to use the Services Provided That it shall only be for personal use and strictly not to be used for commercial gain.

2.3 The Member hereby agrees that the Promoter and the Service Provider does not in any way guarantee the availability of the Services as it is provided on a best effort basis and is subject to the availability of parking spaces and service in the Establishments at any given time and only during the operating hours of the Service Providers.

2.4 The use of the Services is subject to the prevailing terms of conditions of each individual Service Providers in the provision of the Services and in the event of any conflict between the terms herein and the Service Providers's terms of conditions, then the Service Providers's terms of conditions shall prevail.

2.5 The Member hereby agrees that the list of the Establishments as published by the Promoter through any means of electronic or non-electronic communication channels including but not limited to websites, emails, brochures, advertisements and any promotion materials may be changed or revised by the Promoter from time to time at the Promoter's absolute discretion without any prior notice.

### 3. MEMBERSHIP CARD

3.1 The Member shall be issued with One (1) Membership Card which must be presented to the Service Providers at all times in order to enjoy the Services. In the event that the Membership Card is lost or damaged, the Member shall immediately contact the Promoter's helpdesk to have the Membership Card replaced at a fee of RM20.00.

3.2 The Membership Card shall remain the property of the Promoter which the Member shall return to the Promoter upon termination of this Agreement.

3.3 The Member shall adhere to the Promoter's guidelines on the use of the Services and the Membership Card which may be changed or revised by the Promoter from time to time at the Promoter's absolute discretion without any prior notice.

3.4 At the expiry of the term of the membership, Provided That there are no arrears owing by the Member, the membership shall be automatically extended subject in all other respects to the same conditions stipulations and covenants herein contained including this Clause for renewal unless the Member shall within One (1) month prior to the expiry of the term or the extended term give a notice in writing to the Promoter informing that the Member does not wish to extend the term.

3.5 The Promoter shall be entitled to terminate the membership at any time without assigning a reason thereto in which case the Promoter shall refund any Membership Fee (hereinafter defined) paid in advance but pro rated for the unexpired term and the Promoter shall not be liable to the Member or the holder of the Membership Card or any other party whatsoever for any loss and/or damage caused thereby and the Member shall save harmless and fully indemnify the Promoter against all claims, demands, action, legal proceedings expenses loss and/or damage whatsoever in respect thereof. Notwithstanding the aforesaid, in the event that termination is due to breach by the Member of any term herein, then any Membership Fee paid in advance shall be absolutely forfeited to the Promoter as damages which said forfeiture shall not release the Member from any liability arising from the breach for which the Promoter may seek compensation under the law.

### 4. PAYMENT OF MEMBERSHIP FEE, ETC.

4.1 The Member hereby agrees to pay the Promoter the monthly fees (hereinafter referred to as "the Membership Fee") stipulated in the membership application hereto set forth against the type of Membership Package chosen by the Member which said Membership Fee shall be payable in advance on the first (1st) day of each month.

4.2 In the event that the membership commences on a day that is not the first (1st) day of the month, the membership fee for that month payable by the Member shall be pro-rated from the date of commencement to the last day of the month. The Membership Fee for the following months shall be payable in advance on the first (1st) day of each month as usual.

4.3 For the purpose of payment of the Membership Fee, the Member shall simultaneously with the execution of this Agreement sign an authorization form/letter authorizing the Promoter to auto debit the Member's credit card for all payments due.

4.4 The Member shall settle all other charges payable to the Promoter as provided herein within Seven (7) days after becoming due and payable.

4.5 The Promoter may increase and/or vary the Membership Fee and the Excess Parking Fees from time to time at the Promoter's absolute discretion.

4.6 In the event of increase in Membership Fee, the Promoter shall give at least Thirty (30) days advance notice to the Member before the increase is effected (hereinafter referred to as "the Promoter's Notice") to allow the Member to terminate the membership. In the event the Promoter does not receive a notice in writing from the Member to terminate the membership within Thirty (30) days from the date of the Promoter's Notice, the Member shall be deemed to accept the increase in Membership Fee and where required, the Member shall within Seven (7) days upon request by the Promoter sign an authorization form/letter authorizing the Promoter to auto debit the Member's credit card for payment of the increased Membership Fee.

### 5. RISK

5.1 The Member hereby acknowledges that the Service Providers are not partners, agents and/or employees of the Promoter but merely independent contractors.

5.2 The Member hereby agrees that the use of the Services is strictly at the own risk of the Member and/or the holder of the Membership Card. The Member shall exercise discretion when using the Services provided by the Service Providers.

5.3 The Member hereby acknowledges that no condition, warranty or representation is given or made by the Promoter or its business

associates or any of its employees, officers, personnel, representatives, customers or agent with respect to the Services or the reliability or trustworthiness of the Service Providers or the security of the Establishments or security of the Members' vehicle or the things therein placed in the possession of the Service Providers. All other conditions, warranties, guarantees or representation, express or implied, statutory or otherwise as to the state, nature, quality, description or otherwise of the Services or which arises from a course of dealing, usage, law or trade practice are hereby expressly excluded to the fullest extent permitted by law.

5.4 For the avoidance of doubt, in no event shall the Promoter or its business associates or any of its employees, staff, officers, personnel, representatives or agents be liable to the Member whether in contract, tort (including any negligence whatsoever) or otherwise in respect of any claim action or proceedings brought by a third party or by the Member whatsoever for any loss or for any direct, indirect, special, incidental, consequential damages, or for any injury caused or suffered by a person or death of any person or damage to property or any damages arising out of or in connection with the Services or this Agreement, whether or not the Promoter or its business associates or any of its employees, staff, officers, personnel, representatives or agents was or should have been aware of the possibility that such damage or loss would occur notwithstanding that the action was not authorised or capable of being authorised by the Member.

5.5 The Promoter shall not be liable to the Member and/or the holder of the Membership Card for any losses, damage, liabilities, costs and expenses whatsoever which the Member and/or the holder of the Membership Card may sustain arising from the use of the Services including but not limited to damage or theft of their car or things in their car.

5.6 The Member hereby irrevocably and expressly undertake to keep the Promoter, its assigns and/or successors in title, well and sufficiently indemnified against all liabilities, actions, claims, losses, damages, costs and expense whatsoever and howsoever arising from the use of the Services including all costs and expenses incurred in enforcing or seeking to enforce the indemnity herein.

### 6. OTHER TERMS AND CONDITIONS

6.1 The Member hereby agree that the acceptance of the Membership Fee or any part thereof by the Promoter shall not be deemed to operate as a waiver by the Promoter of any right or action against the Member in respect of any breach by the Member of any of its covenants herein contained. No failure or reasonable delay on the part of the Promoter in exercising any right under this Agreement shall operate as a waiver of such right nor shall the knowledge or acquiescence by the Promoter of any breach of non-observance or non-performance by the Member of any terms and conditions of this Agreement constitute a waiver of such and/or any other terms and conditions, unless expressly agreed to by the parties.

6.2 The Promoter reserves the right to amend, by way of variation addition and/or deletion, the terms and conditions of membership herein at any time whatsoever at the Promoter's absolute discretion.

6.3 Time whenever mentioned in the Agreement shall be of the essence of Agreement.

6.4 Any notice required to be served pursuant to this Agreement shall be in writing and shall be served on the other party at their respective addresses or email address or facsimile no. stated herein or at such other addresses as either party may from time to time appoint for the service of notices. A notice shall be deemed to have been sufficiently given if sent by ordinary post on the expiration of five (5) days after the envelope containing the same was delivered into the custody of the postal authorities notwithstanding that the same is returned undelivered and if the same is forwarded by facsimile or email, then service shall be deemed made at the time the facsimile or email is sent.

6.5 Any condition term stipulation provisions covenant or undertaking of this Agreement which is illegal prohibited or unenforceable in any jurisdiction shall as to such jurisdiction be ineffective to the extent of such illegality voidness prohibition or unenforceability without invalidating the remaining provisions hereof and any such illegality prohibition or unenforceability in any jurisdiction shall not invalidate or render illegal void or unenforceable any such term condition stipulation provision covenant or undertaking in any other jurisdiction.

6.6 The parties hereto agree and confirm that this agreement shall be governed by and construed in accordance to the laws of Malaysia and that the parties shall be subject to the non-exclusive jurisdiction of the Malaysian Courts.

6.7 Where the context so permits the term "Member" shall include the Member's invitees, employees, agents, workmen, servants and/or licencees.

6.8 The parties hereto agree that in the event the Promoter sells or transfers the ownership of 'The Valet Club', the Promoter shall be absolutely entitled to assign this Agreement together with the Promoter's powers, rights, obligations and liabilities whatsoever as stipulated herein to the purchaser or transferee, as the case may be, without the need for prior consent of the Member.

6.9 The Schedules hereto are essential parts of this Agreement and in the event of any conflict between the terms herein and that stipulated in the Schedules, the conditions stated in the Schedules shall prevail.

6.10 The headings in this Agreement are inserted for convenience only and shall not affect the construction of the clauses herein.

6.11 This Agreement hereto constitutes the entire agreement between the parties hereto and supersedes in all respects all previous arrangements between the parties hereto whether written oral or implied.

### 7. MEMBERSHIP PACKAGES DETAILS

#### Premier Membership

- Free Valet Service with a maximum of 4 hours parking per entry, limited to one entry per day for each Establishment on weekdays and weekends\*.

#### Platinum Membership

- Free Valet Service with a maximum of 3 hours parking per entry, limited to one entry per day for each Establishment on weekdays and weekends\*.

#### Classic Membership

- Free Valet Service with a maximum of 2 hours parking per entry, limited to one entry per day for each Establishment on weekdays\* only.

\* Weekdays: Monday to Thursday & Friday before 6pm.  
Weekends: Friday after 6pm, Saturday, Sunday & Public Holidays.

The following terms and conditions shall apply to all types of Membership Package :

1. Parking fees for every hour or part thereof in excess of the free parking duration for each entry (herein referred to as "Excess Parking Fees") shall be at the Service Providers' discretion subject to a maximum of RM5.00 per hour or part thereof.
2. The entitlement to valet parking at every Establishment shall be limited to a cumulative of Forty (40) hours only per month per Establishment and may be varied by the Promoter from time to time at their absolute discretion.
3. For any re-entry on the same Establishment on the same day, the member will have to pay the normal valet service fees as stipulated by the Service Providers.
4. Provided That there are no arrears owing by the Member and subject to the approval by the Promoter, the Member shall be entitled to upgrade its Membership Package at any time during the validity of this Agreement which said upgrade shall take effect from the 1st day of the following month after the Member has duly made a request in writing to the Promoter and signed an authorization form/letter authorizing the Promoter to auto debit the Member's credit card for the increased Membership Fee.
