DESCRIPTION

The property consists of 2 adjoining lots of a corner and an end two storey shop office bearing postal address No. 103 & 104, Jalan Hulu Pasar Besar, 16200, Tumpat Kelantan.

Site

The adjoining lands which consist of a corner and an end shop office lots are rectangular in shape. A corner lot has a titled land area of about 140.0 square metres (1,507 square feet) whilst the end lot has a titled land area of about 124.0 square metres (1,336 square feet).

The site has a combined frontage of 16.19 metres (53.13 feet) onto Jalan Hutu Pasar Besar and a depth of 16.30 metres (53.48 feet). The lands are flat and lie at the same level with the road frontage i.e. Ja tan Hulu Pasar Besar.

<u>Building</u>

a) Construction

The buildings consist of a corner and an end 2 storey shop office constructed of reinforced concrete framework, plastered brick walls, reinforced concrete floor slabs and cement tiled roof.

The vertical access within the building is via spiral staircases.

The main entrance to the building is secured by 2 pairs of swing glass panel doors whilst the other internal doors are either of timber flush or aluminium framed glazed panels doors. The windows are of timber casement with glass infill and adjustable glass louvres. The ceiling finishes are of cement plaster and suspended

mineral fibre boards. The floor finishes are either of ceramic tiles, cement render or carpeted.
