Raya Paling Gempak (RPG)

Terms & Conditions

Raya Paling Gempak (RPG) (the "Campaign") is organised by Malayan Banking Berhad (196001000142) ("Maybank") and shall be subject to the Terms and Conditions herein. By participating in this Campaign, the Eligible Participants (as defined in Clause 1 below) hereby expressly agree to be bound by these Terms & Conditions and any decisions made by Maybank in respect of the Campaign shall be final and binding.

1.0 Eligibility and Platform

- a) This Campaign is open to all Maybank and non-Maybank customers residing in Malaysia ('Eligible Participants').
- b) This Campaign is only accessible through the new Maybank web (www.maybank2u.com.my) and the new Maybank2u MY app (6.7 version).

2.0 Campaign Mechanics and Conditions

- a) The Campaign commences on 10 May 2020 until 26 June 2020 ('Campaign Period'),
- b) During the Campaign Period, the Maybank2u MY App will consists of:
 - (i) eDuit Raya
 - (ii) Raya Donation to MaybankHeart
 - (iii) Roda Gempak game

3.0 eDuit Raya

- a) To participate, the Eligible Participants must download and install the new Maybank2u MY app from the Google Play Store or the Apple App Store on their Android or iOS device(s) respectively.
- b) The Eligible Participants must firstly launch the new Maybank2u MY app, then select the eDuit Raya icon and proceed to send eDuit Raya to friends and family.

- c) There are two ways of sending the eDuit Raya;
 - (i) 'Send with QRPay' through the 'Scan' and 'Receive' function ("RayaQR")
 - (ii) 'Send Money' by sending the eDuit Raya via MAE (3rd party transfer through Maybank's new e-wallet, which is accessible to everyone, including participants who do not have a Maybank account).

RayaQR - The Eligible Participants must launch their QRPay function (either via the Maybank2u MY App or MAE) and 'Scan' the recipients' QR code. For the recipient, he or she will have to launch their QRPay function and choose 'Receive' to produce their unique QR code to the person giving them the eDuit Raya. This can be done when both sender and recipient are physically present. The sender will stand a chance to spin the Roda Gempak when he or she successfully performs this transaction.

Send Money - The Eligible Participants will have to choose the eDuit Raya function in MAE and choose the recipient name through their contact list. The sender will stand a chance to spin the Roda Gempak once the money has been successfully transferred to the recipient's MAE account.

- i) If the receiver is already registered with MAE, the eDuit Raya will immediately be credited into the receiver's account.
- ii) If the receiver is not registered with MAE, the eDuit Raya will only be credited from the sender's account once the recipients' MAE account has been successfully activated. The sender will be informed that the recipient is not yet an MAE customer and he or she will be able to send a message to the recipient to encourage the opening of an MAE account to receive the eDuit Raya.
- iii) The minimum age to receive the eDuit Raya via MAE is 12 years old. This follows the minimum age requirement to open an MAE account.
- d) There is no limit to the number of times a sender can send eDuit Raya to the same recipient. However, only the first eDuit Raya transaction will receive a guaranteed chance to spin Roda Gempak. There is a maximum of five (5) chances to spin the Roda Gempak that can be earned from each unique user or receiver.
