# MCampus 2022 - Terms & Conditions

- 1. 'MCampus 2022' ("Event") is organized by Malayan Banking Berhad (196001000142 (3813-K) (referred as "Maybank"). The Event is only open to "Eligible Participants" as defined at clause 4.
