

## Terms & Conditions - Double Your Rewards Campaign FY2024

- 1. The "Double Your Rewards Campaign FY2024" ("Campaign") commences on 17<sup>th</sup> Oct 2024 and expires on 31<sup>st</sup> Dec 2024 (both dates inclusive), unless notified otherwise ("Campaign Period").
